In addition, each member is allocated their share of net margins of the Cooperative on an annual basis. Patronage dividends are distributed to the members subject to available cash flow and based on approval by the board of directors.

Each year, the governing body appoints a nominating committee. The nominating committee meets and nominates a slate of candidates to run for election to the governing body. Nominations by petition are also accepted for candidates to run for election to the governing body. The candidates are placed on a ballot and members of the organization vote at an annual meeting to elect members of the governing body. Voting is allowed in person at the meeting, by mail in ballot, or by proxy.
